



Picture 1. Front view of battery 图片 1. 电池组前视图




Picture 2. Back view of battery 图片 2. 电池组后视图



Picture 3. Front view of cell 图片 3. 电池前视图




Picture 4. Back view of cell 图片 4. 电池后视图


