个人预防措施、保护设备和应急程序： 如果电池被泄露，让人员离开该区域直到烟雾消散。提供最大限度的通风，清除有害气体。首选的反应就是离开这个地区并消散气体，避免皮肤和眼睛接触或吸入气体。用吸收剂清除溢出的液体然后焚烧。如果电池泄漏发生时，液体可以用砂、泥土或其他惰性物质来吸收，污染区域应该保持通风。 Personal precautions, protective equipment and emergency procedures: If the battery is released, remove personnel from area until fumes dissipate. Provide maximum ventilation to clear out hazardous gases. The preferred response is to leave the area and allow the vapors to dissipate. Avoid skin and eyes contact or inhalation of vapors. Remove spilled liquid with absorbent and incinerated. If leakage of the battery happens, liquid could be absorbed by using sand, earth or other inert substance and contaminated area should be ventilated meantime.

If battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules, Avoid leached substances to get into the earth, canalization or waters.
